**AGREEMENT: TERMS & CONTRACT**

This agreement is between Kevin Sheehy and all participants going on any of the tours provided by Tours For Travelers. No other businesses, nor owner, are a party to this agreement

**RESERVATIONS & PAYMENT**

A non-refundable deposit of \$500 per person is required to hold your space. I accept Visa, MasterCard, Discover, Checks or Cash. Full payment must be received 45 days prior to departure.

**TRAVEL DOCUMENTS**

For travel abroad, a valid US passport with an expiration date at least 6 months beyond return date for all US citizens is required. Other nationalities please inquiry with me. If you do not have a passport begin the process now as it may take up to 6 weeks to obtain a US passport.

Airline tickets are completely your responsibly and must be purchased by you.

A Turkish visa is required and can be purchased on arrival at the Istanbul airport. Visas are not required for Americans entering Israel.

Travel insurance is highly recommended for unforeseen possibilities.

**ACCIDENT, DENTAL AND EMERGENCY**

While traveling accidents can happen. You are responsible for health, dental, emergency medical evacuation and repatriation expenses. Check with your travel agent and health care provider for details.

**CANCELLATION FEES**

- 45+ days prior to departure – \$500 deposit is retained by me.
- 45 to 30 days prior to departure – 75% of trip cost is retained.
- 30 days or less prior to departure – 100% of trip cost is retained.

Tours for Travelers reserves the right to cancel the tour if a minimum of 10 people is not reached 60 days prior to the start date. In this event, there would be a 100% refund or the option of putting that payment towards a future trip to that or any destination that we serve.

**INDIVIDUAL TRAVEL AND PERSONAL PURCHASES**

Any independent travel, i.e. travel not on the scheduled itinerary, whether during free time, before or after the trip is your sole responsibility.

All alcoholic beverage purchases, except as noted on the itinerary, are your personal responsibility.

**GENERAL LIABILITY**

You are responsible for your own personal activities while on the trip, especially while on your own time. All travelers are expected to act responsibly for the betterment of the trip and the respect of the other travelers. The undersigned does waive all claims against Kevin Sheehy which may arise out of this agreement or the trip.
